Distinctions

Widener Law offers you many opportunities to earn an unparalleled legal education leading to a distinguished career. The Delaware Campus provides a fantastic starting point for careers in corporate law. The Harrisburg Campus excels in governmental law.

The first step toward a distinguished career awaits you at either campus. This opportunity is evidenced by Widener Law's many remarkable distinctions:

Widener Law, one of the largest law schools in the mid-Atlantic, is the only law school in Pennsylvania's state capital and in the state of Delaware.



More than 12,000 Widener Law alumni practice in 48 states, the District of Columbia, and 25 countries. There are 101 alumni serving in the judiciary and more than 700 CEOs, CFOs, and corporate board members.

Widener Law publishes four law reviews, including *The Delaware Journal of Corporate Law*, which is ranked first among student-edited "Corporation and Association" journals and 11th as the most cited law review by federal and state courts (Washington & Lee University School of Law study, 2009).

■ Widener Law's special programs are renowned: the Health Law Institute in Delaware ranks among the nation's top health law programs; the Environmental Law Center at both campuses houses the Environmental and Natural Resources Law Clinic wherein students have successfully litigated more than 200 claims; and the Law and Government Institute in Harrisburg offers four certificate programs all with close ties to Pennsylvania government.

Our faculty and administration routinely receive high-level appointments: Delaware Gov. Jack Markell named Dean Linda L. Ammons to lead an independent review into the state's policies and procedures relating to sexual assault cases; Professor Lawrence A. Hamermesh is serving as an attorney fellow with the Securities and Exchange Commission in Washington, D.C.; and the Pennsylvania Bar Association appointed Professor John L. Gedid to the Constitutional Convention Commission.



Prestigious, Accessible Faculty


Widener Law's faculty includes former and current judges, former prosecutors, public defenders, and attorneys from all types of practice large and small firms, government agencies, and public interest settings. They advise state and federal court systems, state legislatures, Congress, local bar associations, and international organizations. Many faculty members are known for their contributions to corporate, health, international, labor, constitutional, administrative, and environmental law.

Vice President Joseph R. Biden taught a class on constitutional law as an adjunct professor for 17 years before he joined the Obama Administration.

Professor John C. Dernbach, director of the Environmental Law Center, served for two years as director of the Pennsylvania Department of Environmental Resources policy office.

Professor Geoffrey H. Moulton Jr. has served in the U.S. Department of Justice as First Assistant U.S. Attorney for the Eastern District of Pennsylvania and is currently serving as chief counsel to Delaware senator Ted Kaufman.

We are committed to your success. The Widener Law curriculum builds a solid foundation in the fundamentals of law. You may further refine your studies by selecting classes in specific areas.

During the first year, academic support programs are available to assist you in making the transition to the study of law. Classes and workshops on study and test taking techniques as well as individual assistance are offered to help you hone your analytical and writing skills.

Seminars have 6 to 20 students per class, and small section courses between 30 to 40 students. Typical first-year required classes have approximately 80 students, but some are as small as 25.



The faculty members here come from great educational backgrounds and are very skilled in their areas of law. In addition to the JD program, Widener Law offers various dualdegree programs that allow you to obtain two degrees in less time than it would take to pursue each separately.

- Juris Doctor/Master of Business Administration (JD/MBA), a collaborative effort with Widener University School of Business Administration.
- Juris Doctor/Doctor of Psychology (JD/PsyD), a collaborative effort with Widener University Institute for Graduate Clinical Psychology.
- Juris Doctor/ Master of Public Health (JD/MPH), a collaborative effort with Thomas Jefferson University.
- Juris Doctor/Master of Marine
 Policy (JD/MMP), a collaborative
 effort with the University of Delaware.

Juris Doctor/Master of Science in Library Science (JD/MSLS), a collaborative effort with Clarion University of Pennsylvania.

Law Clinics

Widener Law operates clinics, arranges externships and public interest legal placements, runs trial simulations and advocacy training, and much more to help you build the skills you will need from day one of your legal career. Experiencing the law at work—in legislative sessions, death penalty hearings, and federal cases—brings your classroom learning to life.

Widener Law offers an extensive list of clinical opportunities allowing you to obtain hands-on experience representing clients while in law school. On the Delaware Campus, you may choose the Delaware Civil Law Clinic, Environmental Law and Natural Resources Clinic, Pennsylvania Civil Law Clinic, Pennsylvania Criminal Defense Clinic, or the Veterans Law Clinic.

On the Harrisburg Campus you may choose the Harrisburg Civil Law Clinic, the Veterans Law Clinic, or the Environmental Law Clinic.

Externships: Second- and thirdyear externships provide you with opportunities to work with state and local prosecuting attorneys, public defenders, legal services lawyers, and government agencies. As a judicial extern, you get a look at the inner workings of the court system while conducting legal research and drafting documents for judges.



Institutes and Centers

Widener Law's institutes and centers allow you to develop your expertise in specific areas of law while earning your juris doctor degree.

• The Law and Government Institute in Harrisburg offers certification in governmental law with specialties in constitutional/administrative law, or legislation. The Law and Government Institute, in conjunction with the Environmental Law Center, also offers a certificate in environmental law.

■ The Business Organizations Law Certificate Program in Delaware offers the opportunity to develop a fundamental knowledge of business law.

The Health Law Institute in Delaware ranks among the nation's top law programs and prepares students for the fast-changing world of health law.

■ Widener Law's *Taishoff Advocacy*, *Technology and Public Service Institute* in Delaware offers a trial advocacy program giving students an opportunity to develop their knowledge of and proficiency in the fundamental skills essential to becoming competent, professionally responsible advocates. The institute also provides a certificate program in criminal law.

■ The *Environmental Law Center* in Delaware offers an Environmental Law and Policy Certificate allowing you to concentrate your study in environmental and natural resources law.

■ The Advocacy Certificate Program in Harrisburg offers you the opportunity to hone your advocacy skills through a series of skills courses, clinical trial opportunities, and dispute resolution courses. Ę

Journals, Honor Societies, and **Organizations**

Journals: Legal research and writing are important parts of any successful legal career. You can perfect those skills by working on *The Delaware* Journal of Corporate Law (Delaware), the Widener Law Review (Delaware), the Widener Law Journal (Harrisburg) and the Widener Journal of Law, Economics, and Race (Delaware and Harrisburg).

Moot Court Honor Society: You can participate in moot court honor societies on both campuses. As a member, you can earn academic credit for a variety of moot court activities, including participation in



interscholastic competitions, while perfecting your oral advocacy and brief writing skills.

Trial Advocacy Honor Society: Both campuses also offer a Trial Advocacy Honor Society, which provides additional opportunity for you to hone your advocacy skills.

Organizations: With more than 60 activities and organizations on our two campuses, you will be surrounded by opportunities for professional development and network building.

If you think Widener Law is a place where you will succeed, you are ready to apply. Applying online is free at **law.widener.edu**

Admission Policy: Admissions decisions consider undergraduate GPA and the LSAT, work and life experiences, extracurricular activities, community involvement, and graduate study. Although not required, a personal statement and letters of recommendation are highly encouraged. Widener Law is committed to diversity and encourages women and members of minority groups to apply.

Widener Law admissions facts you should know

- Widener Law requires electronic applications through law.widener.edu or the Law School Admissions Council Credential Assembly Service Electronic Application at www.lsac.org
- The application deadline is May 15.
- Choose from full- or part-time programs with day or evening classes.
- Apply to one or both campuses using one application. Applicants applying to both campuses waive their choice of campus in most instances.
- The Trial Admissions Program (TAP) is a conditional admission program for applicants who demonstrate potential for success in law school despite being competitive on only one of the two principal standardized measures of success—undergraduate GPA or LSAT. All applicants are considered for TAP.

A simplified enrollment program exists for graduates of the 14 Pennsylvania State System of Higher Education (PASSHE) universities applying to the Harrisburg Campus before April 1.

- Transfer and visiting students are accepted in any semester after completion of one full year of law school.
- Previous law school attendees
 must submit a certified transcript and
 letter of good standing from that school.
- International applicants must submit a completed application before April 1.
